



## Summer Freedom Drop-In Program

At Fremont Community School for ages 3 to 6

**Open Monday through Friday**

**June 7-September 3, 2010**

**Morning hours: 9:00am-1:00pm**

(Four hour program)

**Afternoon hours: 1:00pm-5:00pm**

(Hourly program, 2 hour minimum)

Are you looking for a fun, relaxed, flexible summer school for your children?



FCS is a small, non-profit preschool nestled between Fremont and Wallingford, just north of Lake Union. Our school house is situated in an orchard of fruit trees, where our children have full time access to outside play. Our resident rabbit happily hops around with the children while they play in our harbor of “pirate ships”, dig in our garden, splash in the water table or simply run around.

Inside we focus on imaginative play. Children dress up and construct “castles” or “caves” or “stages”, depending on what they are pretending at the moment. Arts and crafts are available to those wishing to participate, with a special focus on nature and natural fibers. Activities are always age appropriate.

Snack is provided during the morning program. It is always healthy and very often organic. Children bring their own (peanut-free) lunch and afternoon snack (if they are here beyond 1:00).

This program is run with family time in mind. You can opt to come daily or weekly or randomly, whichever best fits your needs.

Summer Freedom offers a discount for pre-paid hours purchased before May 14. The discounted rate applies to all additional hours purchased throughout the summer. Children at preschools can only be on site for a maximum of 4 hours per day. If you anticipate needing more than 4 hours of care per day, you may purchase pre-paid hours for our sister school next door, Tara's Tots, for those additional hours. All prepaid hours are NON-REFUNDABLE and NON-TRANSFERABLE. Summer Freedom is open to the greater Seattle community, so invite your friends! FCS also offers Summer Art Camps for ages 4-11 years old.

Please check how many pre-paid hours you would like to purchase. These hours can be used at any time throughout the summer and you can purchase more at anytime. The more you pre-pay before May 14, the lower your rate. (Please note that the morning program is only a 4 hour program. The afternoon is 2, 3 or 4 hours):

**BEFORE MAY 14, 2010**

60 hours - \$450. Additional hours purchased will be billed at my locked in rate of **\$7.50/hour**.

20 hours - \$175. Additional hours purchased will be billed at my locked in rate of **\$8.75/hour**.

40 hours at both FCS and Tara's Tots - \$300 to FCS, \$300 to Tara's Tots. Must be purchased at the same time. Additional hours purchased at either school will be billed at my locked in rate of **\$7.50/hour**. (PLEASE SUBMIT A TARA'S TOTS REGISTRATION FORM AS WELL.)

**AFTER MAY 14, 2010**

40 hours - \$350. Additional hours purchased will be billed at my locked in rate of **\$8.75/hour**.

\$10/hour – if registering after May 14, all time will be billed at **\$10/hour**.

I would like to pre-register for the following days/dates/times. Be sure to indicate AM or PM program and hours for the PM program. Remember, if you reserve a space in advance and then are unable to attend, **you must cancel a week in advance to avoid being charged.**

**Please read and initial the following to indicate your understanding and agreement.**

\_\_\_\_\_ I understand that the morning program runs from 9:00am-1:00pm and I will be charged 4 hours for this program.

\_\_\_\_\_ I understand that if my child attends the morning program and is not picked up by 1:00 or registered for the afternoon program, my child will be sent to Tara's Tots for the afternoon program and I will be billed at my locked in rate until I arrive.

\_\_\_\_\_ I understand that the afternoon program is hourly from 1:00pm-5:00pm with a minimum of 2 hours. I will be billed by the whole hour. Example: arriving at 1:15pm and leaving at 3:45 pm will be billed as 3 hours, 1:00-4:00pm.

\_\_\_\_\_ I understand that if my child attends the afternoon program and is picked up after 5:00pm, I will be billed **\$5 per minute** that I am late. This is based on the time on the school clock.

\_\_\_\_\_ I understand that snack will be provided during the morning program, but I am responsible for providing a lunch. In the afternoon program, FCS *does not* provide snack.

\_\_\_\_\_ I understand that if I do not cancel a reservation **a week in advance**, I will be billed for that time. If my child is sick and unable to come, I will be billed. I will not send a sick child to FCS.

\_\_\_\_\_ I understand that prepaid hours are NON-REFUNDABLE and NON-TRANSFERABLE. They can be used for children in the same family and for the FCS Summer Freedom program only. Camps are separate billing.

\_\_\_\_\_ I understand that FCS is a peanut free school.
